Transport for Wales Rail Ltd 14th Supplemental Agreement – Industry Consultation

Seilwaith Amey Cymru / Amey Infrastructure Wales Limited and Transport for Wales Rail Ltd propose to submit to the ORR an application under Section 22 of the Railways Act 1993 for approval of an amendment to their CVL Track Access Contract. In line with the Industry Code of Practice for track access application consultations, we are consulting you on the proposed agreement.

The purpose of the supplemental is to make the following amendments to the Track Access Contract:

 Delete the Schedule 5 Table 2.1a and replace with a version containing the access rights required to facilitate reinstatement of a small number of services on the Rhymney Valley, as a result of reduced engineering access requirements of the CVL Transformation Programme.
